1. No alcoholic beverages, tobacco products, or controlled substances are to be consumed or used while on tour.
2. No boy is to be a girls' room at any time.
3. No girl is to be in a boys' room at any time.
4. All tour members must participate in all features and tours scheduled.
5. All tour members must be on time for bus transfers.
6. There will be a set curfew when all tour members must be in their rooms. Lights out and quiet will be observed
7. Students must always display proper behavior and follow guidelines & instructions set by the GHS Band Staff and Chaperones. This includes any public displays of affection (PDF)
8. All Germantown School District rules for curricular and co-curricular activities apply to the New York Band Tour 2011.

4. Tag Alongs must follow hotel quiet hours.
